# CLEANSING NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001 (CTH)

eMetals Limited (**Emetals** or the **Company**) (**ASX: EMT**), wishes to advise that it has issued 14,800,000 fully paid ordinary shares, as follows:

- As announced on 30 October 2020, the Company has issued 9,800,000 fully paid ordinary shares pursuant to the Binding Term Sheet to acquire 100% of the issued capital of Iron Clad Prospecting Pty Ltd; and,
- 5,000,000 fully paid ordinary shares were issued under an agreement for the Company to purchase 100% of the issued share capital in SOC Resources Pty Ltd, as announced on 4 February 2021.

Details of the Shares issued are contained within the attached Appendix 2A.

The Company gives this Notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) for the issue of 14,800,000 fully paid ordinary shares.

The Shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
