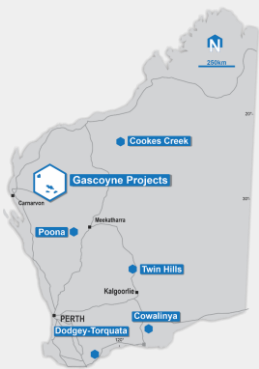

CLEANSING NOTICE UNDER SECTION 708A OF THE CORPORATIONS ACT 2001 (CTH)

The Directors of eMetals Limited (**ASX:EMT**) (**eMetals**) (**Company**) advises that, further to its announcement dated 19 November 2021 and following approval at the general meeting of shareholders held on 6 January 2022, it has issued a total of 265,000,000 fully paid ordinary shares:

- 250,000,000 Tranche 2 Placement Shares at an issue price of \$0.0125 per Share to sophisticated and professional investors, approval received at the general meeting of shareholders held on 6 January 2022;
- 15,000,000 Vendor Shares at an issue price of \$0.02 per Share, approval received at the general meeting of shareholders held on 6 January 2022; and
- The Company has also issued 350,000,000 unlisted options exercisable at \$0.03 on or before 30 September 2025 to Placement participants as approved at the general meeting of shareholders held on 6 January 2022.

Details of the Placement are set out in the Company's ASX announcement dated 19 November 2021 and the Appendix 2A released earlier today.
